

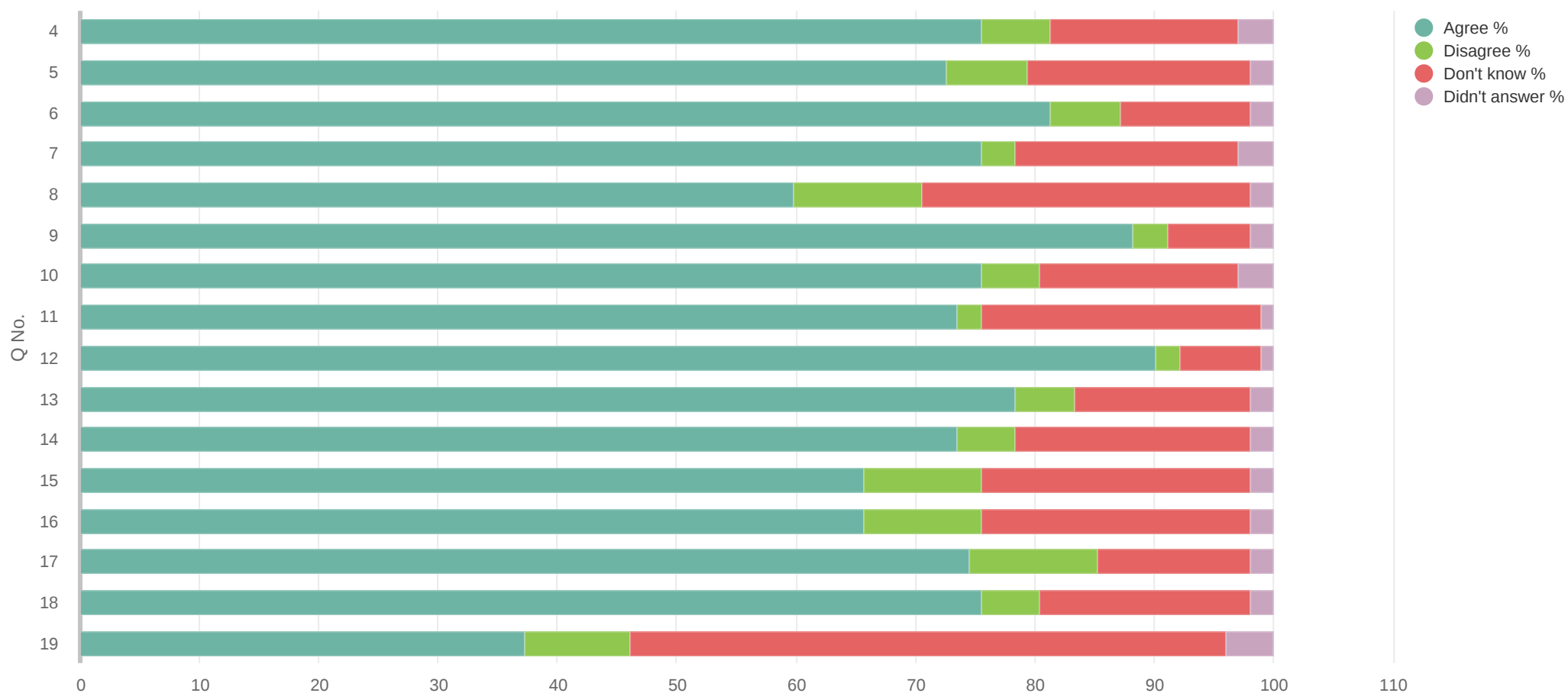

01 Your Experience by Percentage Chart (Sharing)



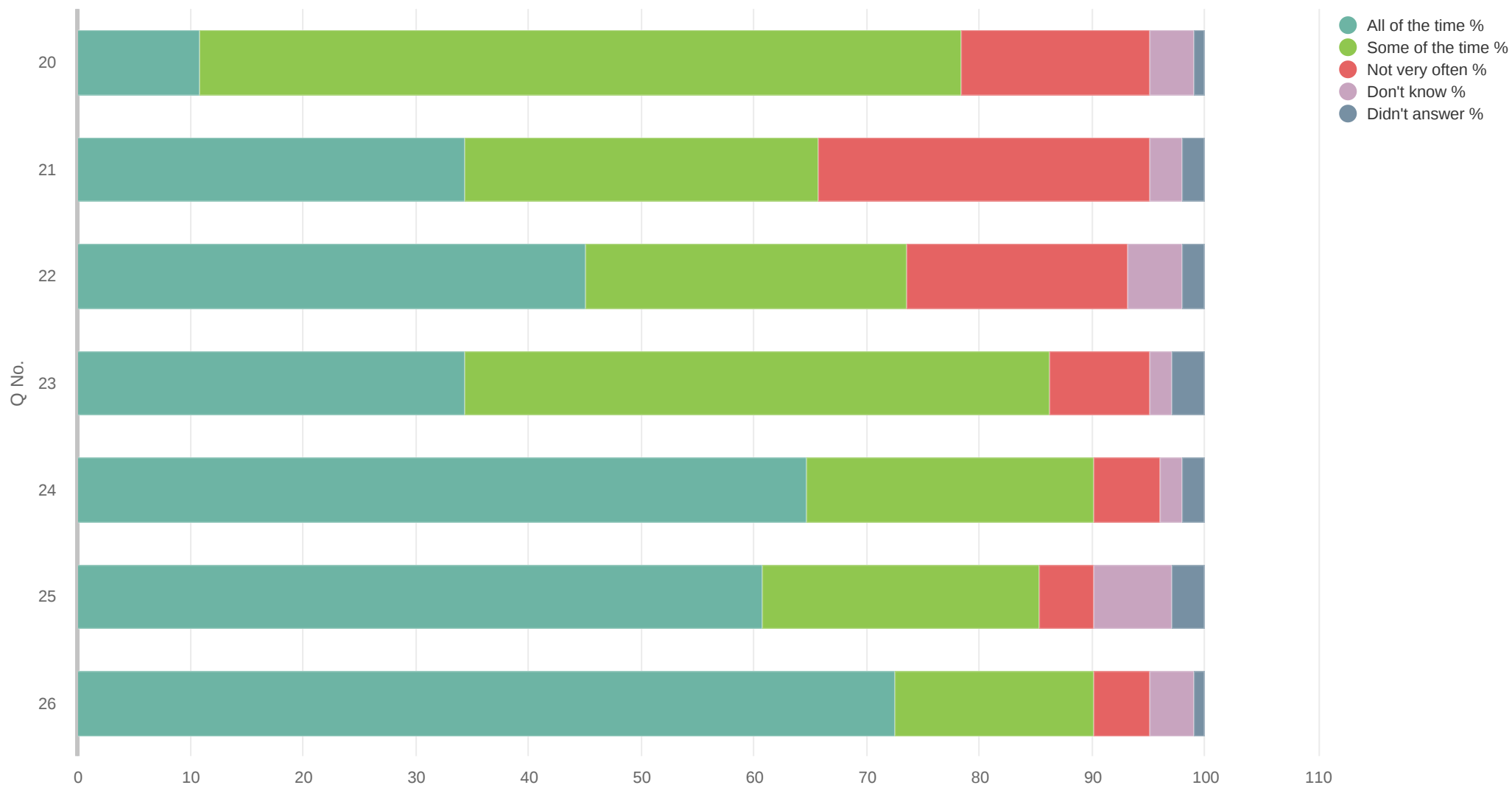

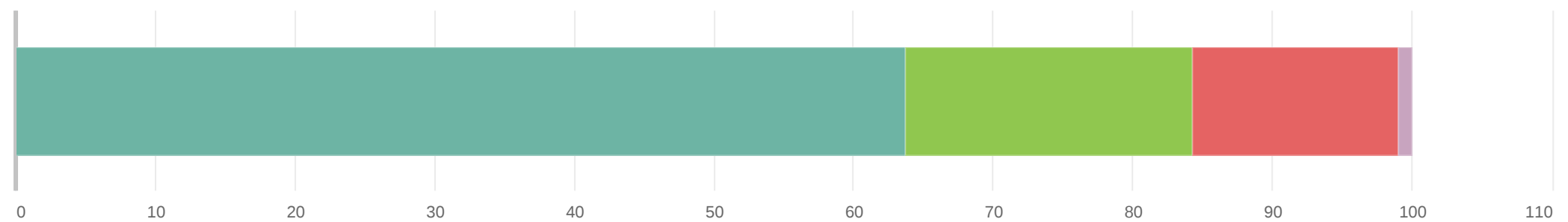

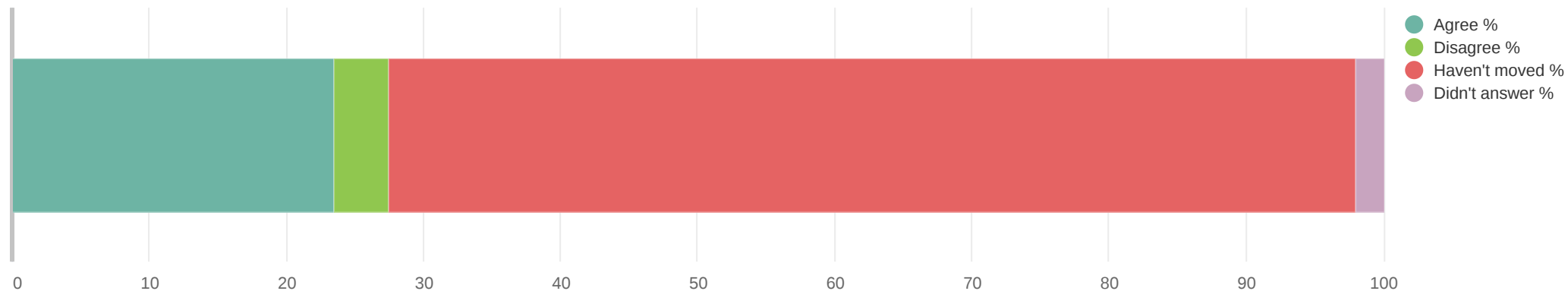
01 Your Experience by Percentage Chart (Sharing) Bullying

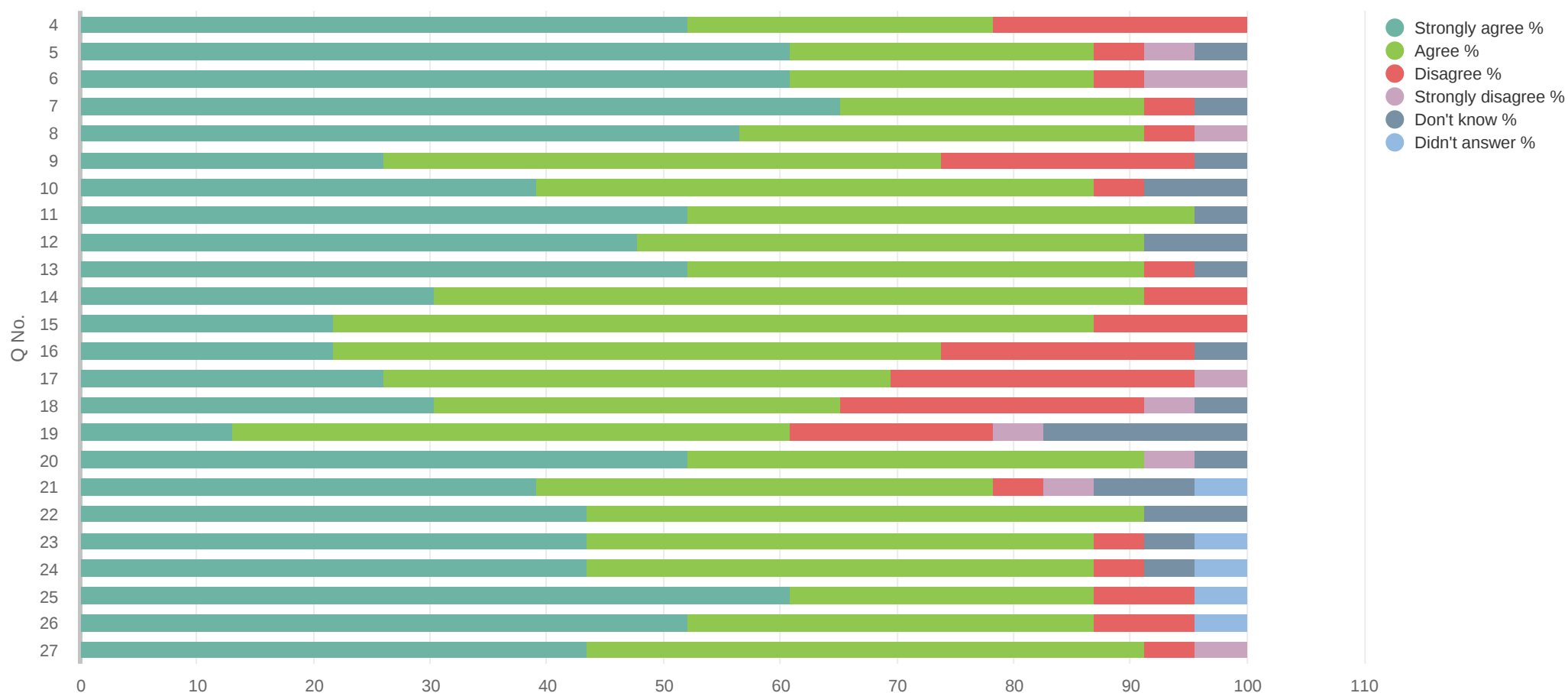

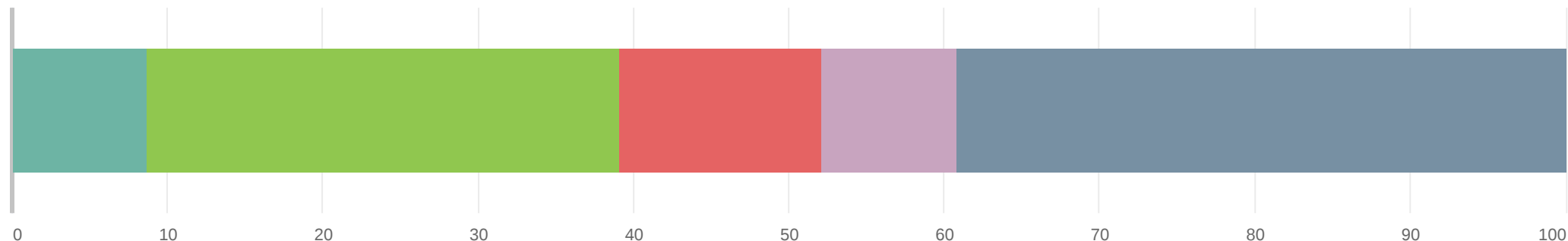
