

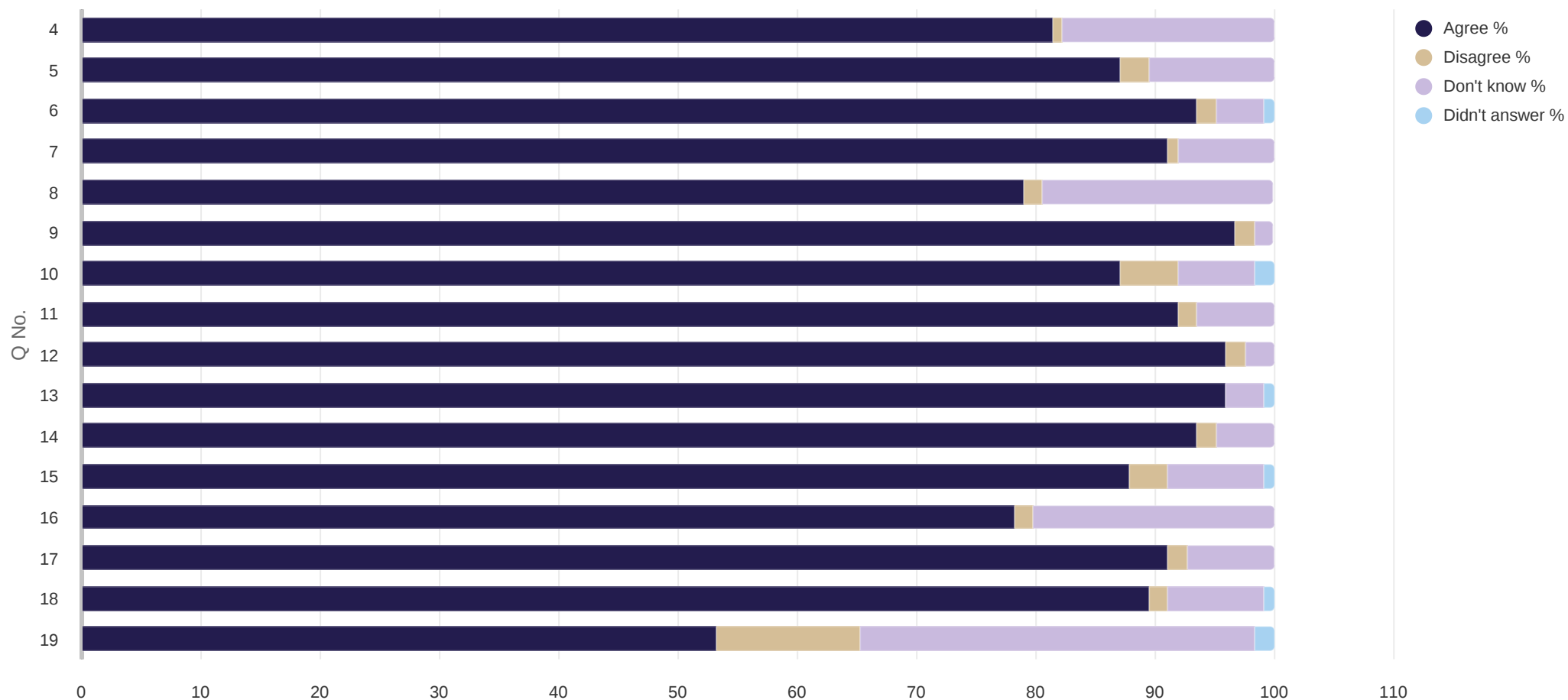

01 Your Experience by Percentage Chart (Sharing)



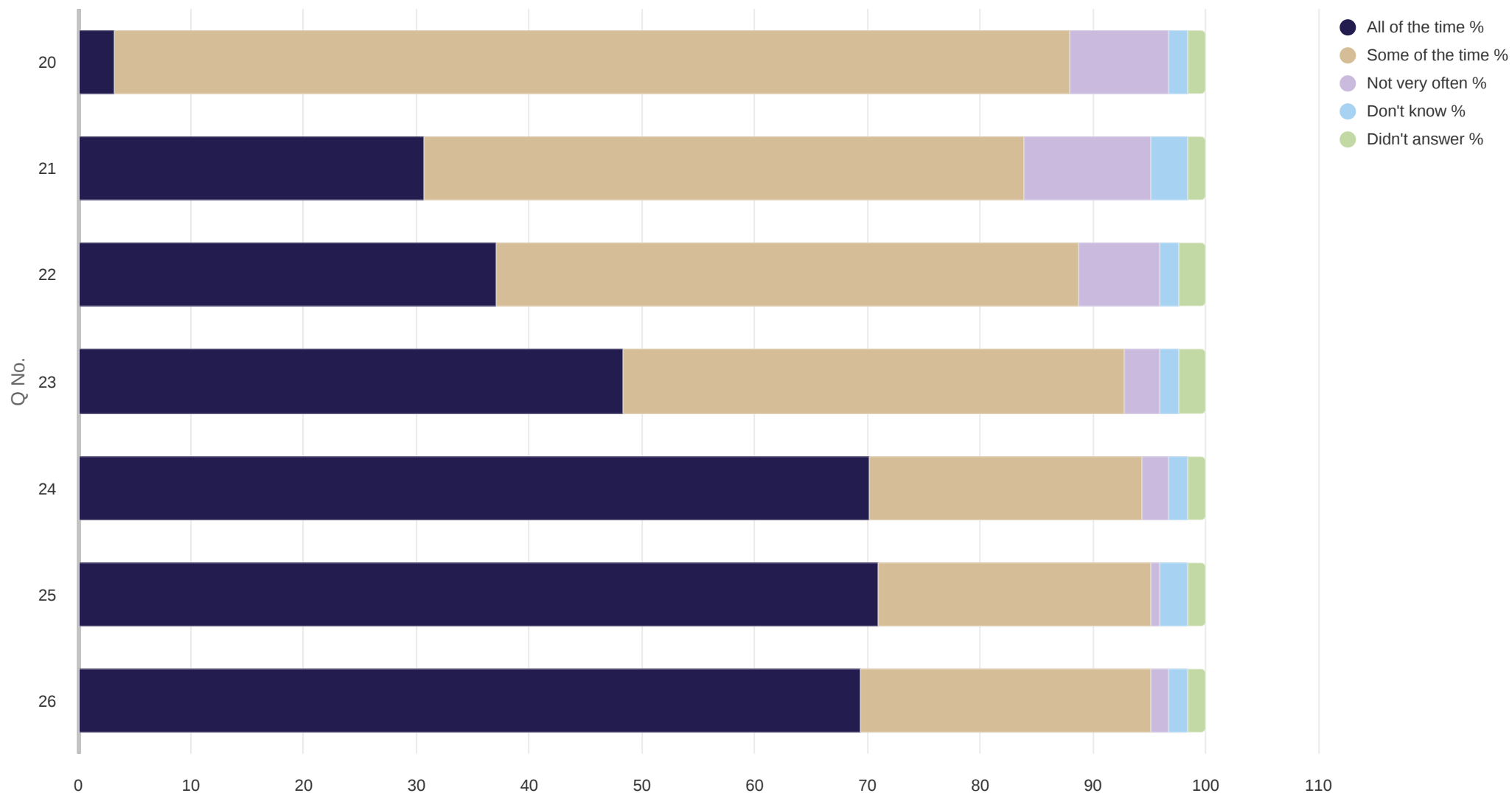

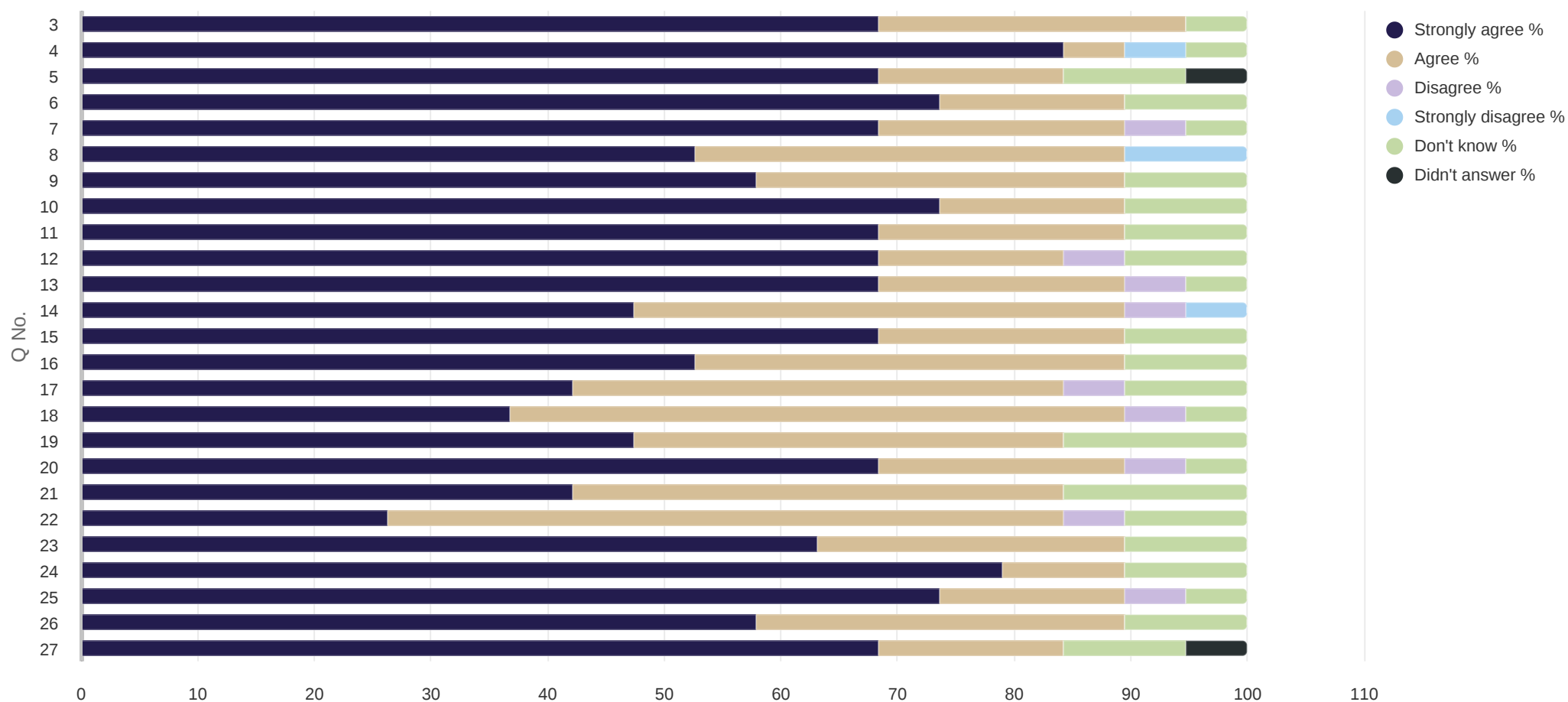
01 Your Experience by Percentage 2 Chart (Sharing)

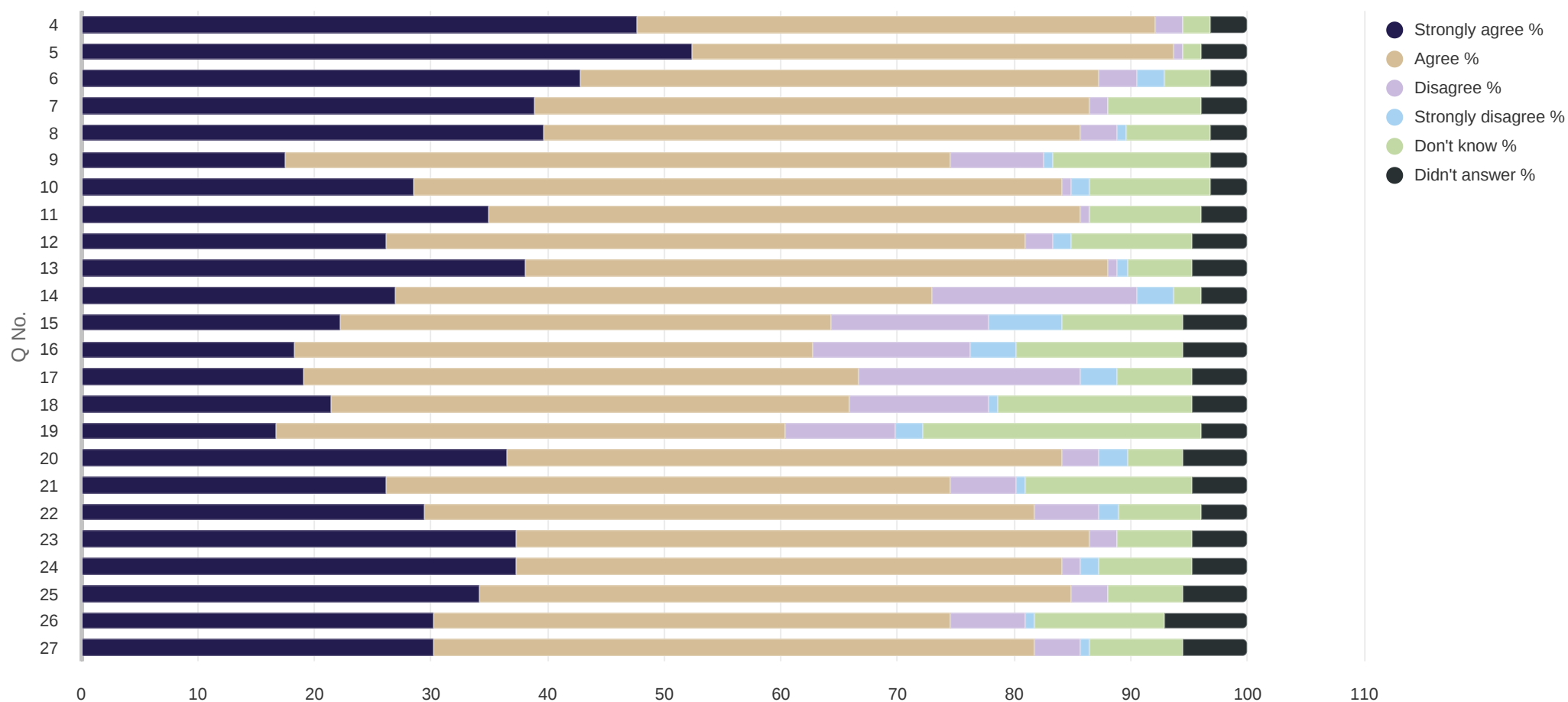

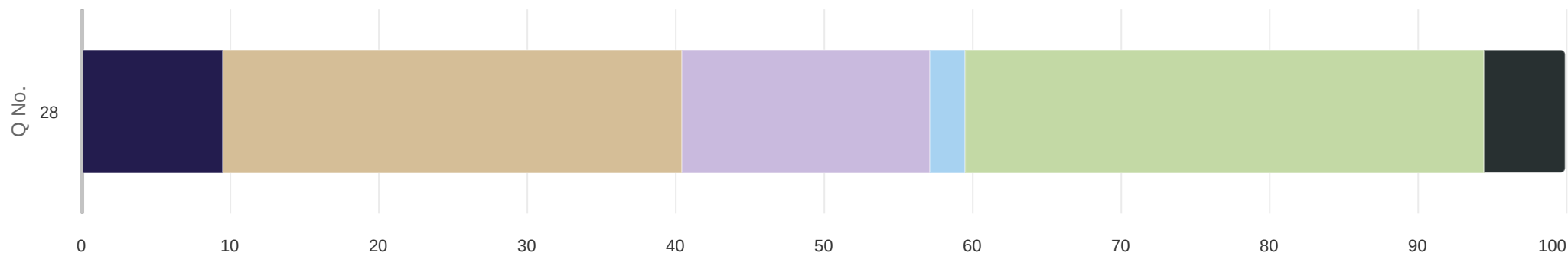

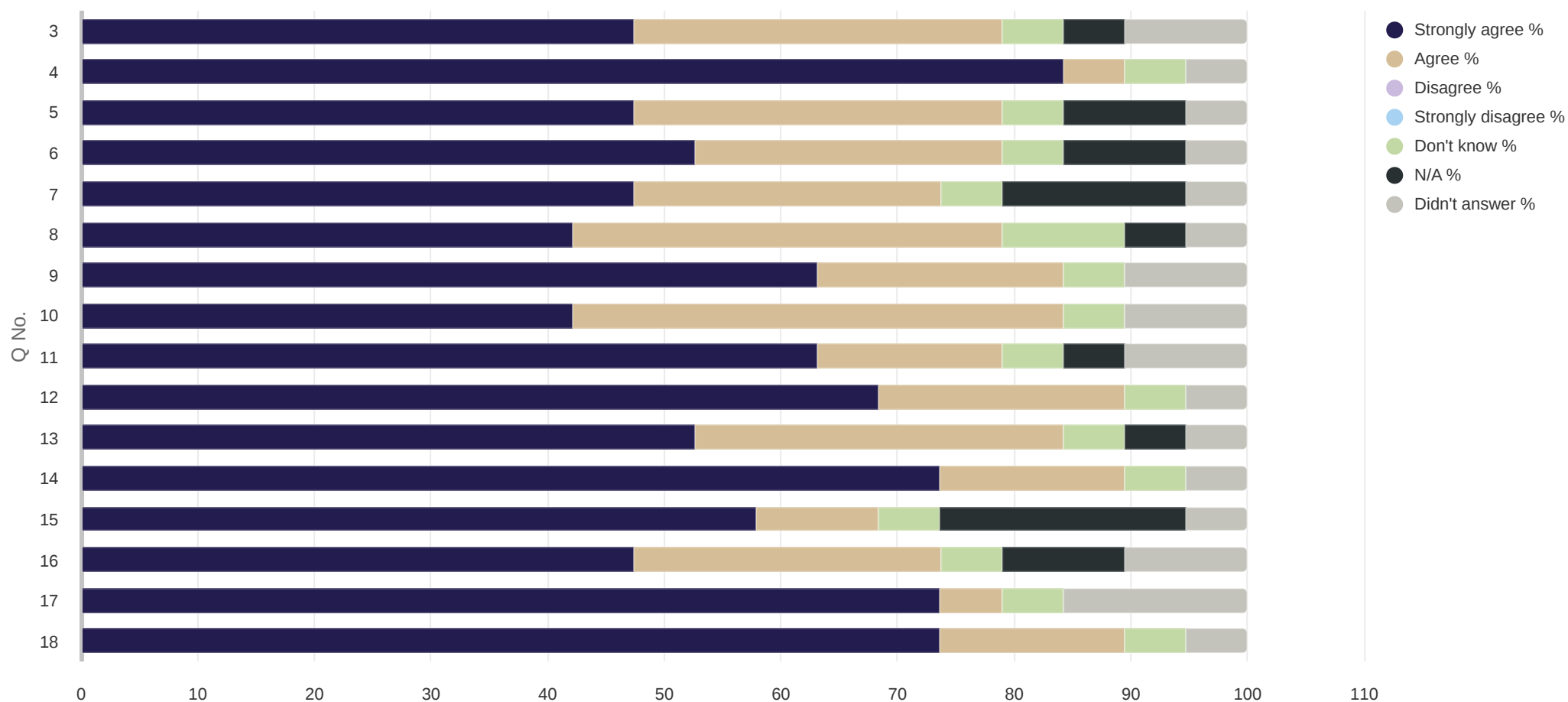

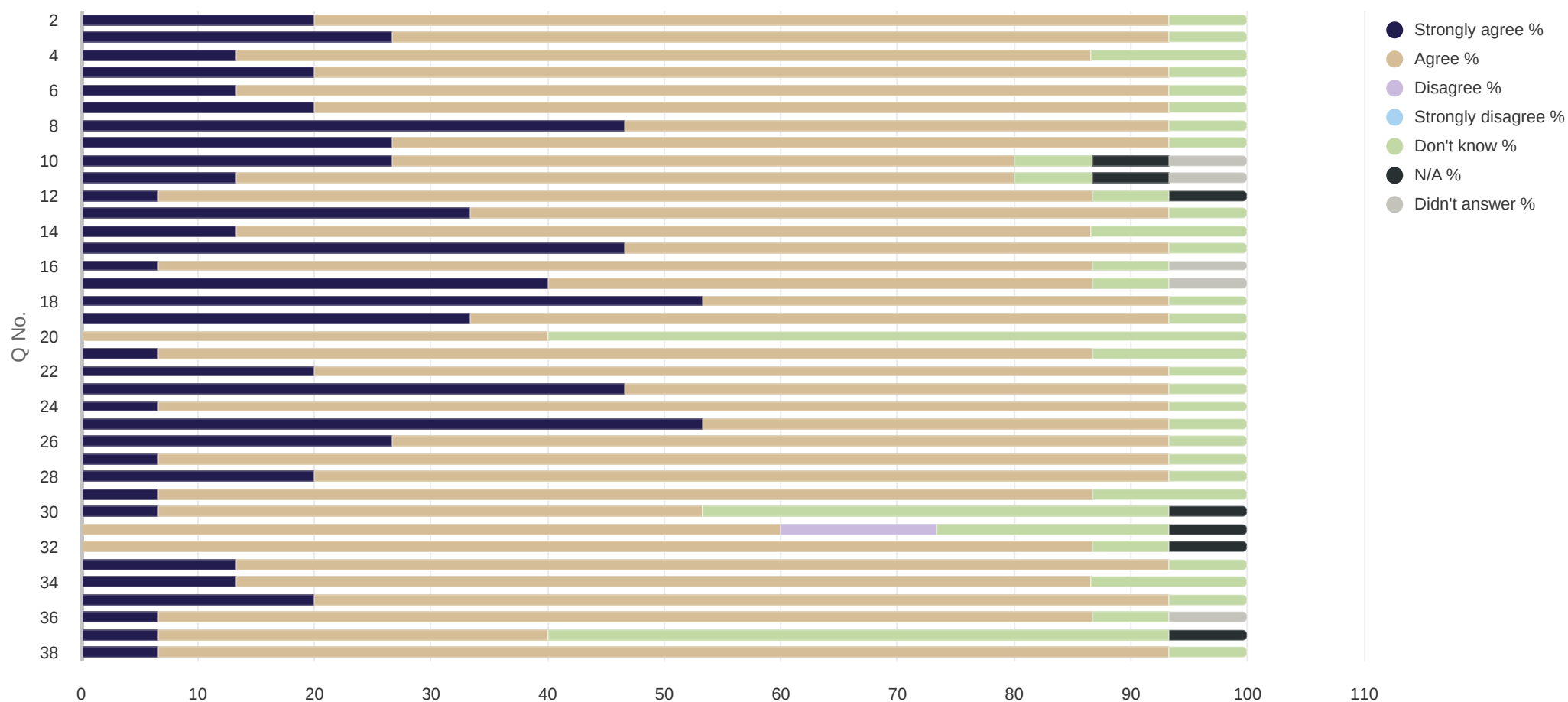
