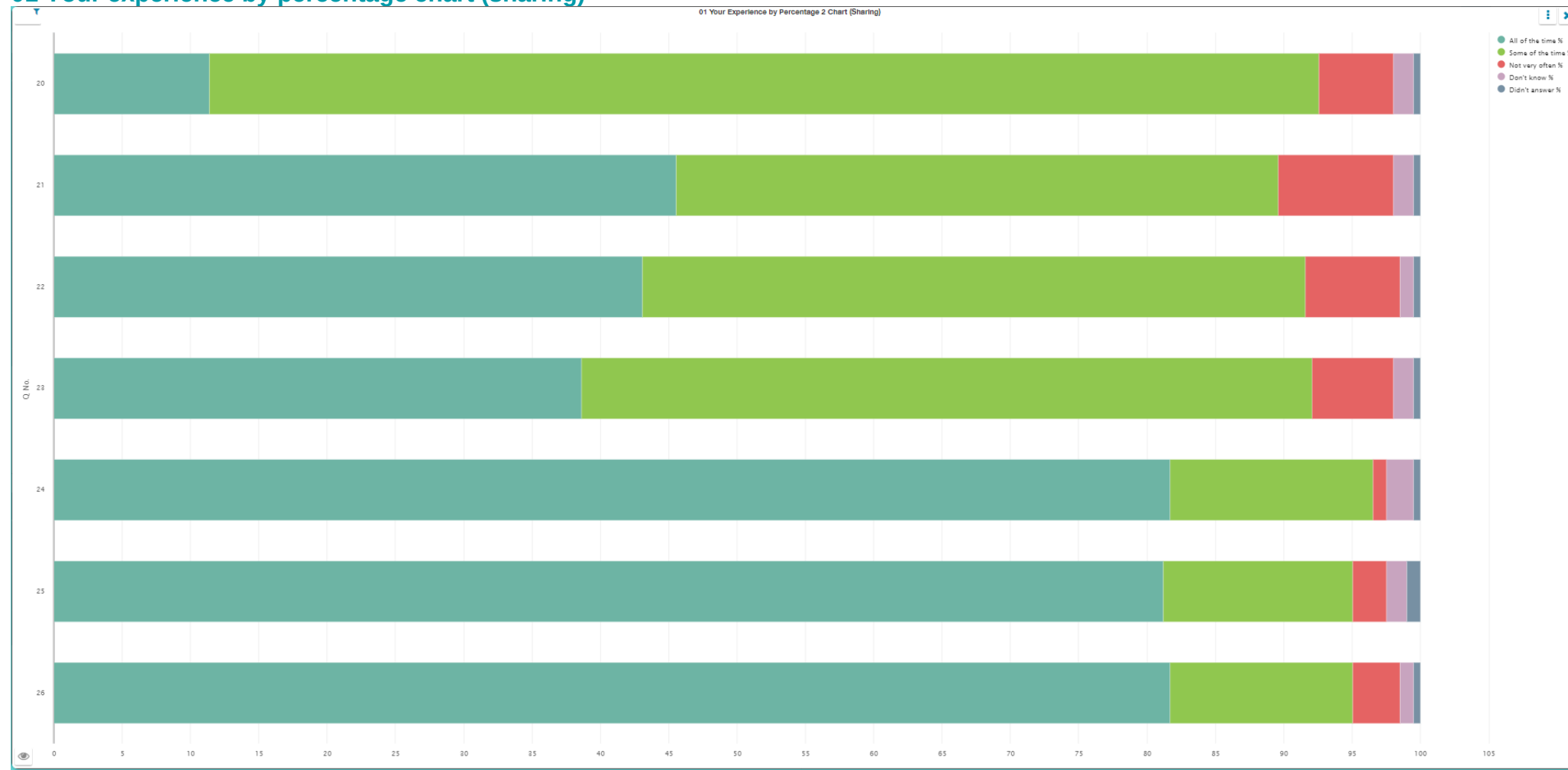

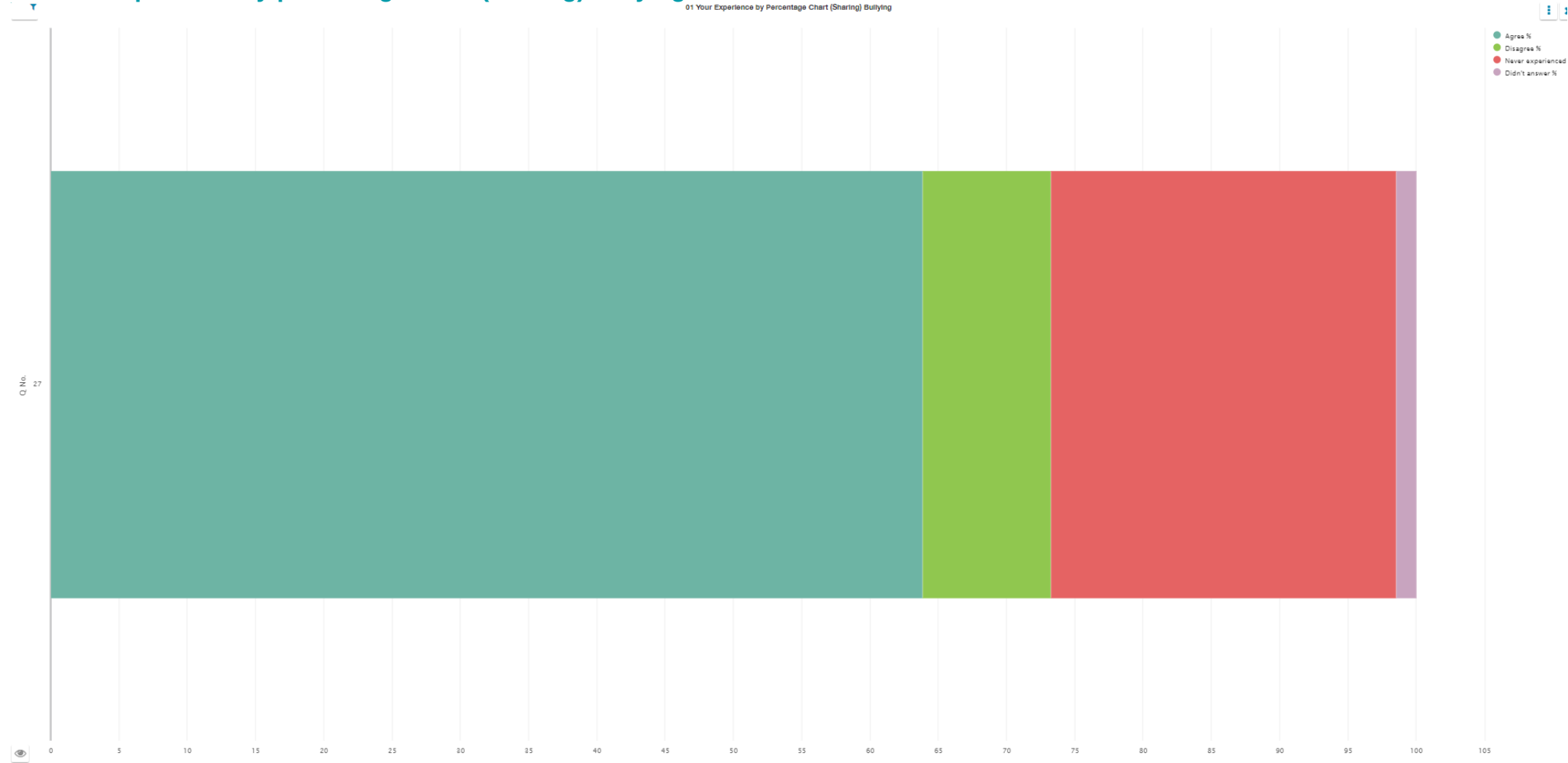

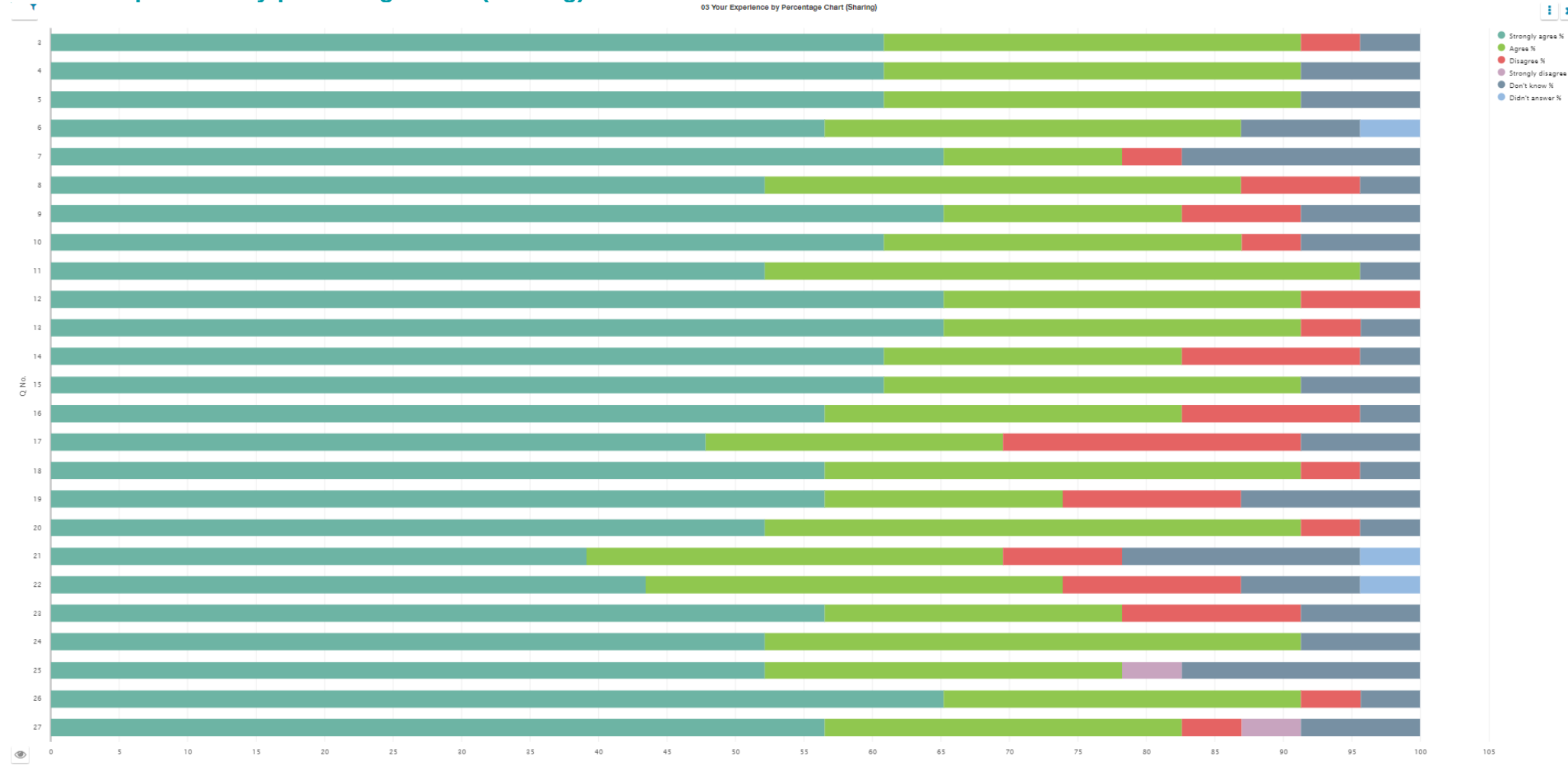

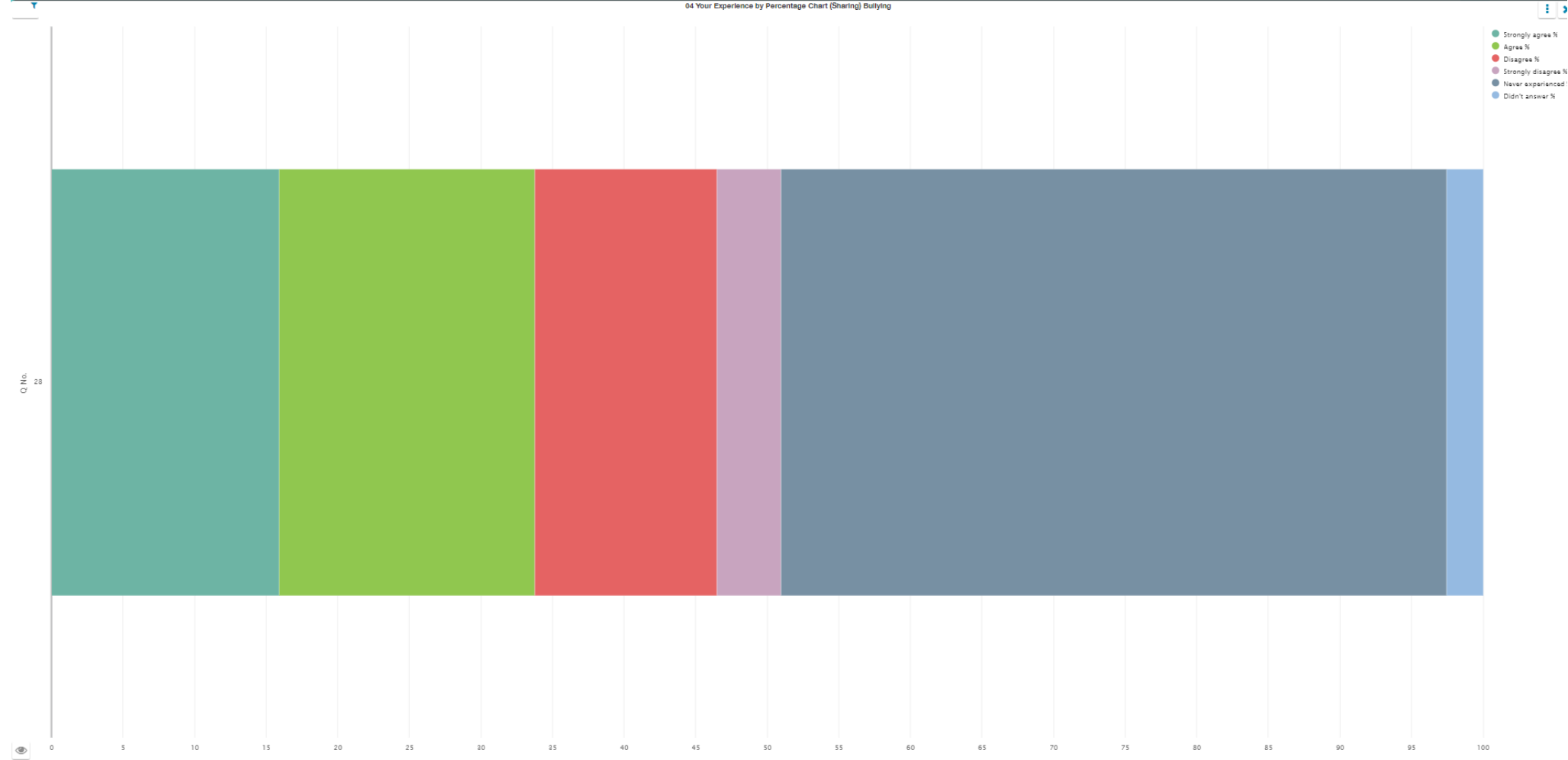
04 Your experience by percentage chart (sharing)

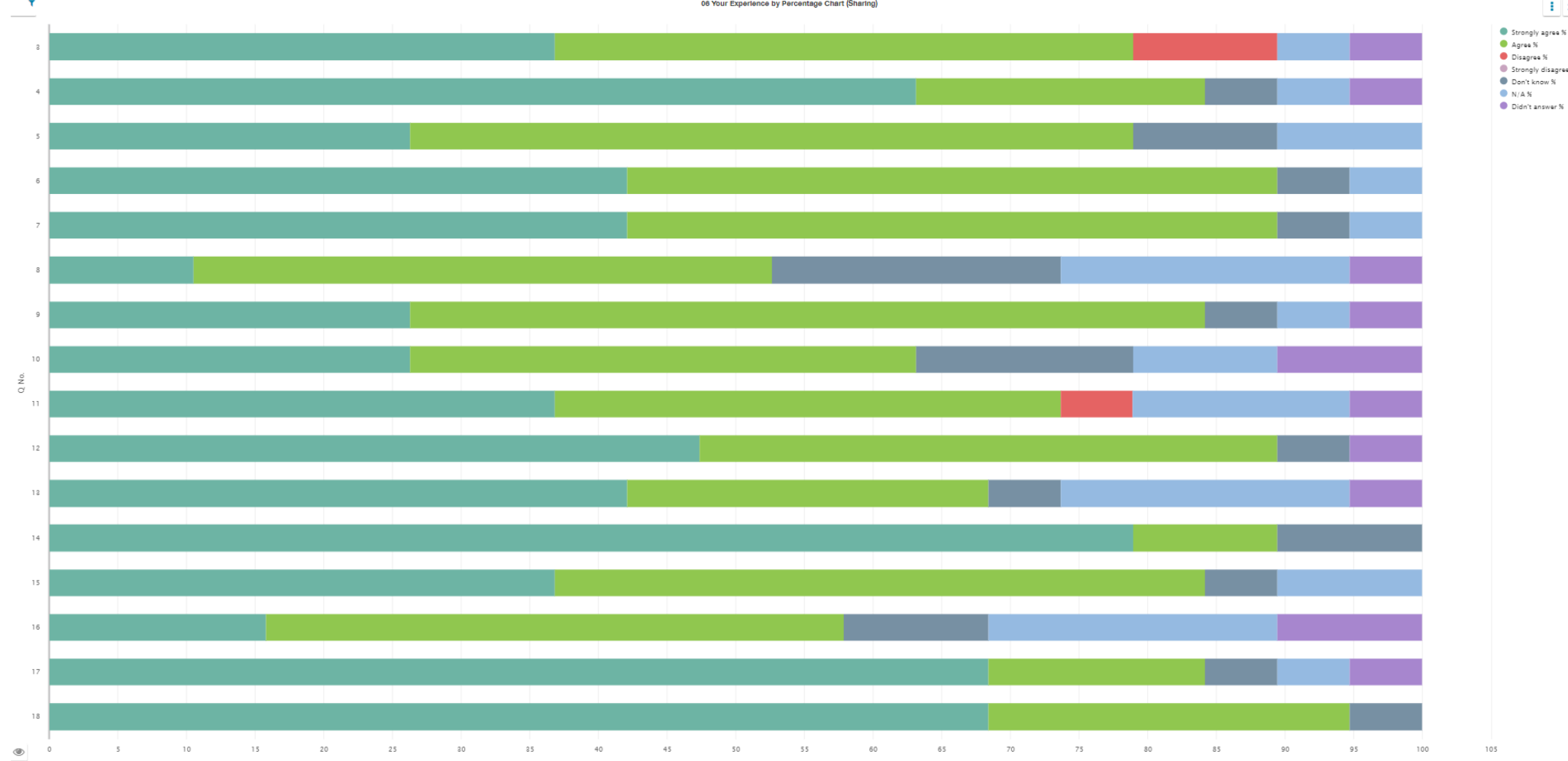

06 Your experience by percentage chart (sharing)



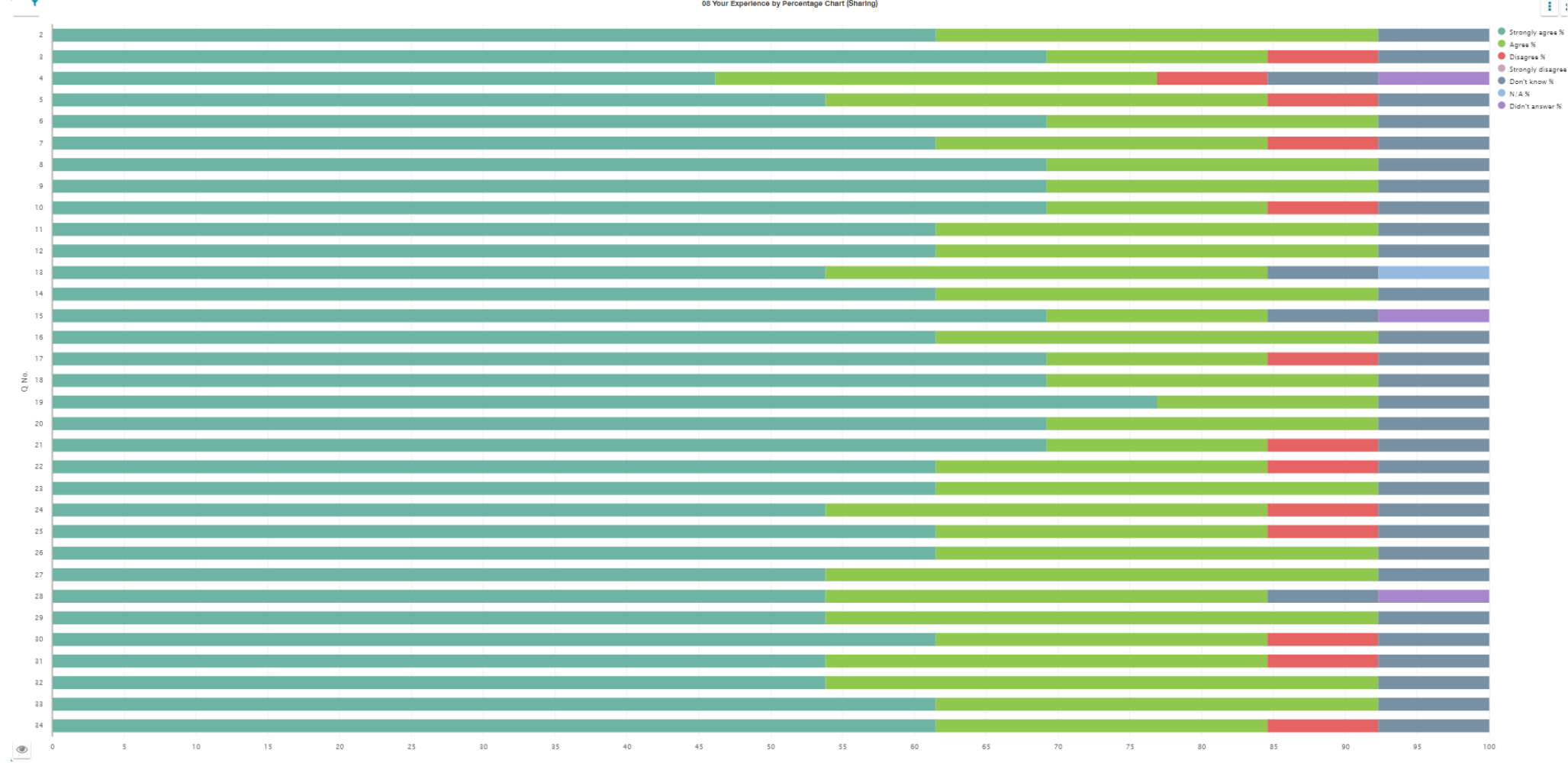

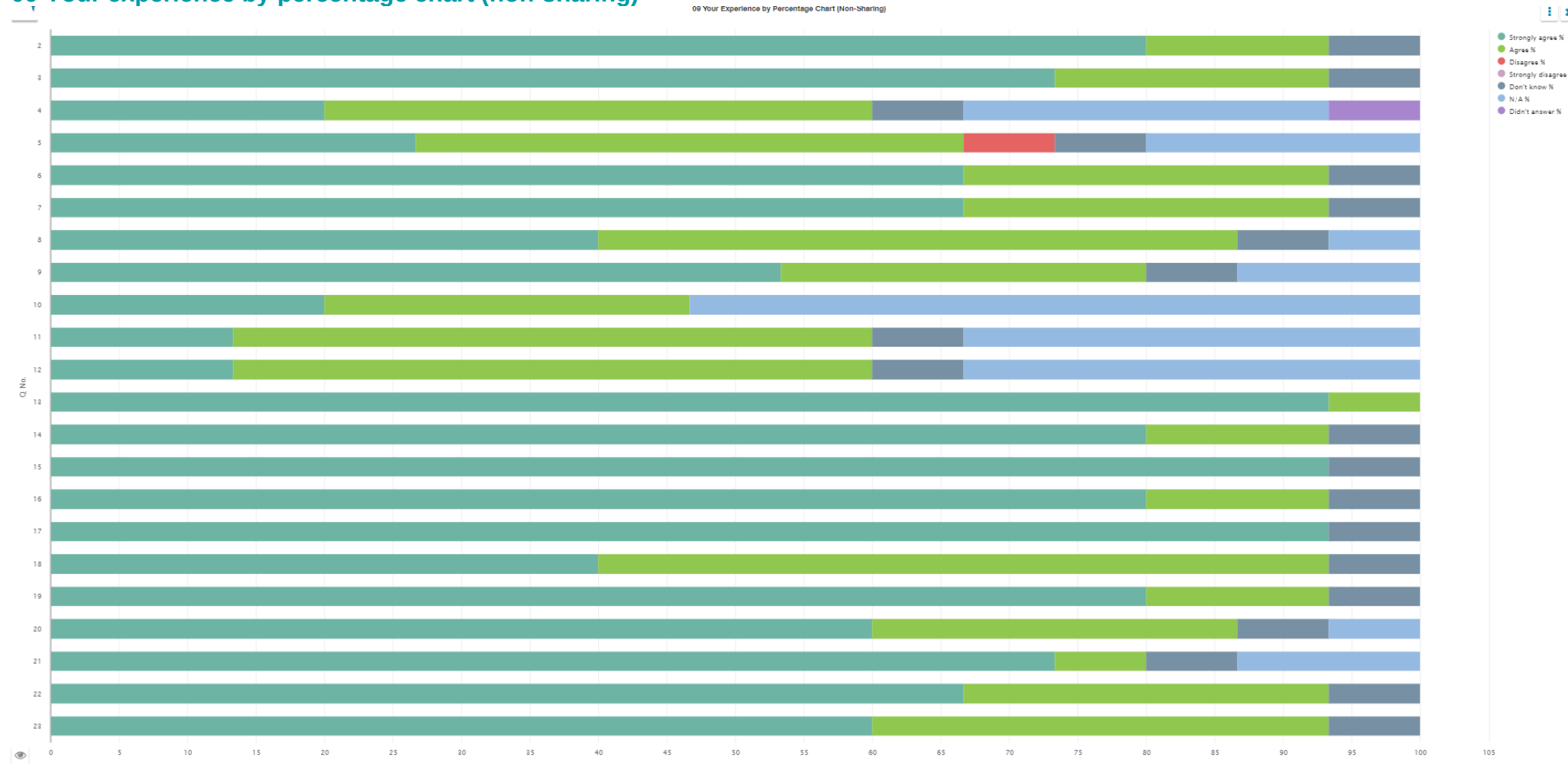
